2017 Summer Vacation Raffle

NSC will once again host an incentive based raffle this summer. NSC will be raffling off a \$2,000 travel voucher. NSC will purchase \$1,900 of the voucher from Swain’s Travel and Swain’s Travel will donate \$100 towards the voucher. Although NSC’s portion to purchase is \$1,900, NSC will set aside the \$100 to cover any additional expenses such as printing of raffle tickets, advertisements and/or a portion of the Massachusetts raffle tax.

Here is how it works:

Based on the # of participants, will determine the minimum number of tickets sold towards your personal incentive.

Once you have sold the minimum # of tickets, the balance sold will be split 60/40: 60% to the participant/skater and 40% to NSC.

Tickets are \$10 each or 3 for \$25. The winning ticket will be drawn the Sunday, September 17, 2017 at the Island Fair. The winner must book their vacation via Swain’s Travel no later than December 31, 2017.

Based on the minimum number of participants, the minimum dollar amount of tickets to be sold is:

- If 10 members participate, the first \$200 worth of tickets sold will go directly to pay for the raffle prize.
- If 15 members participate, the first \$134 worth of tickets sold will go directly to pay for the raffle prize.
- If 20 members participate, the first \$100 worth of tickets sold will go directly to pay for the raffle prize.

If 20 skaters participate and sell:

Tickets sold at \$10	Vacation and expenses cost (\$2,000)	Skater earns (60%)	NSC earns (40%)
30	\$100	\$120	\$80
50	\$100	\$240	\$160
75	\$100	\$390	\$260
100	\$100	\$775	\$225

The 60% will be placed in “escrow” to be used for Nantucket Skating Club classes or clinics as well as Nantucket Ice skating programs or classes, including Synchro or Theatre on Ice tuition and OFS. Funds may NOT be used for private lessons. “Escrow” funds must be used or allocated no later than November 1, 2017 and will be distributed by Nantucket Skating Club once written approval is received by the parent of the skater. The 40% will remain in NSC’s bank account as part of overall fundraising for the 2017-2018 fiscal year.

All participants must execute this agreement no later than Monday, June 19th so that NSC can determine the breakdown. Tickets will be distributed the week of June 26th. Tickets are due to Francine Balling, Raffle Coordinator, no later than 5:00pm, Friday, September 15, 2017. All tickets sold during the Island Fair will benefit NSC 100%

NSC will secure a limited number of opportunities to sell tickets at the mid-Island Stop & Shop. Each time slot will be limited to 2 skaters and at least one adult must be present to supervise. If you choose to secure additional times and/or other locations, please make sure that your skater is present as this is for them and their club and not just raising money. Unlike last year, no cash box, signage, table, etc will be provided. Please arrange to have the appropriate items to represent NSC.

I wish to participate in the Nantucket Skating Club’s summer “Vacation Raffle.” This is an incentive based fundraiser, the more you sell; the more you save. I understand that I will be required to sell or personally purchase the direct proportion of tickets required to pay for the vacation package.

I understand that I will be notified by e-mail the final determined minimum I must sell. I will receive a receipt each time I turn in my raffle tickets and money. NSC will manage ticket distribution, funds received and split for escrow and NSC.

I understand that I must be a current member and in good standing for NSC for the 2017-2018 season.
